ABSTRACT

BIOGRAPHY OR HISTORY

George Haverstick (1926-2000) was born in Wisconsin, worked in Louisiana, then settled in San Diego. He was an attorney in private practice since 1970. He was the president of the San Diego chapter of the American Civil Liberties Union in 1979. Haverstick was dubbed the "Porno Lawyer" and San Diego's best defender of massage parlor entrepreneurs, and sex workers. He was the owner of "Havertsick's Union Street Law" and defended gay men cited for solicitation at rest rooms or parks. Haverstick was also known for his spirituality and relationship with the Episcopalian church.
