This collection contains materials collected before and after the passing of Prop 8. Prop 8 was a discriminatory bill that banned same-sex marriages. The Center, organized by Cara Dessert, gathered volunteers to help canvass voters all across San Diego including North County. Volunteers canvassed neighborhoods and conducted phone banks, urging voters to vote against Prop 8.
